DURING THE COVID-19 PANDEMIC, WE LIMITED CLASSES TO TUESDAY AND THURSDAY ONLY DUE TO LOW STUDENT ENROLLMENT DURING THAT TIME. WE RESUMED IN-PERSON CLASSES IN AUGUST, 2021. CHILDCARE IS TYPICALLY AVAILABLE DURING ALL CLASS TIMES, HOWEVER DURING THE PANDEMIC, WE DID NOT OFFER CHILDCARE SINCE WE HAD NO IN-PERSON CLASSES. THE COMPUTER LAB IS STAFFED 12 HOURS PER WEEK, BUT AVAILABLE FOR STUDENTS TO WORK INDEPENDENTLY DURING ALL BUSINESS HOURS. OBJECTIVE: TO PROVIDE ENGLISH LANGUAGE LEARNING AND CRITICAL THINKING INSTRUCTION TO ENABLE LEARNERS TO BECOME ENGAGED, SELF-SUFFICIENT PARENTS, EMPLOYEES AND COMMUNITY MEMBERS. OVER 400 ADULTS ARE ENROLLED AND ATTENDING ONE OF THE 4 LEVELS OF ENGLISH
